

American Society of Acupuncturists REPORT: 3rd Annual Congress of the ASA Council March 16-18, 2018 Denver, Colorado

The meeting was attended by 27 state associations represented by 41 delegates, as well as representatives from CCAOM, NCCAOM, AAPAS, and DVCIPM. ANF and ACAOM, including a screening of the first segment of "Getting to the Point" – a new film by film maker Doug Dearth via the Acupuncture Now Foundation. Marilyn Allen and the American Acupuncture Council also sponsored a lunch program presenting information on ICD 11 which will include Traditional Medicine codes, and opened discussion for the potential for course development in orthopedic acupuncture. Our evening gathering was generously sponsored by Modern Acupuncture, and we had a valuable breakfast program sponsored by CM&F insurance looking at malpractice coverage options for the industry. Call to Order and Assurance of Quorum

After introductions, the meeting was called to order. Per ASA bylaws, meetings and the business to be conducted must be officially called 30 days in advance, which was achieved with distribution of the agenda to voting members (the Council) 30 days prior. To conduct business, the meeting must be attended by a quorum of the Council, defined as 40% of the voting member organizations. At the start of the meeting, ASA had 27 paid voting member organizations, and there was attendance by 25 of those groups, for an attendance of 93% meeting our quorum. Rules of conduct were reviewed.

Review of 2017 Accomplishments

2017 brought notably increased visibility to not only the American Society of Acupuncturists, but also to the acupuncture industry as a whole. Most importantly, the representation of Licensed Acupuncturists in the U.S. was magnified, and many industry groups, legislators, and regulators began to consider this licensure type as a viable player in the American healthcare marketplace.

ASA representatives attended numerous meetings and conferences of over 2017, including the Pacific Symposium, the Integrative Fertility Symposium, the European TCM Association Rothenburg Congress, the Society for Integrative Oncology annual meeting, the Society for Acupuncture Research annual meeting, the American TCM Association 3rd annual academic conference, the AMA CPT code meetings, the Integrative Healthcare Symposium, and had meetings in Beijing, China with WFAS, WFCMS, and SATCM. We also supported and attended the ISO meetings relevant to Chinese medicine. All of these events provided valuable contacts for the organization and allowed us to help represent both ASA and the United States at the national and international levels.

In November of 2017 the ASA in conjunction with AAPAS also co-lead the first-ever Congressional Briefing for the acupuncture industry. The event was held in Washington, D.C., and was well attended by staff from numerous legislative offices. The impact of this event continues to ripple through the industry, and doors have opened with legislators, other organizations, and the military consequent to this effort.

Working with numerous scholars, ASA helped produce an industry impacting, peer reviewed white paper on Acupuncture's Role in Solving the Opioid Epidemic. ASA also submitted comments to governmental agencies such as the FDA on acupuncture's role as a non-pharmacologic treatment for pain.

The ASA State member organizations were also extremely busy and productive throughout the year, and our new newsletter was developed to highlight this work as well. Please take time to read both our year-end summary and the monthly reports to keep up to date on major activities within the industry.

Our goals for 2018 include (but are not limited to...):

- Development of a comprehensive web platform to advance the industry's cyber presence and better unite the state associations. This platform would also offer a low-cost, high-quality platform for individual practitioners looking to create or improve their web presence.
- Amplified income generation through the development of non-voting supporter categories.
- Expansion and focusing of legislative efforts via the ASA legislative committee.
- On-going maturation of relationships with existing partner organizations such as ACAOM, CCAOM, NCCAOM, TCMAAA/ATCMA, AAPAS, EBA, ANF, ETCMA, SAR, SIO, IHPC, and others.
- Continued refinement of board and leadership manuals.
- Enhanced benefits for member organizations.
- Increased industry visibility.
- Attendance at industry meetings including PCOM, IFS, SIO, the AMA CPT meetings, ISO, EBA, and the Academic Consortium, and World Acupuncture Day a UNESCO event in Paris.
- Board development including identification of future board members.
- Support for the entry of Licensed Acupuncturists in the military.
- Development of a cohesive policy development platform for state associations and the national organization.
- Planning for a 2019 industry-wide, national meeting!





State Member Organization Status Updates

States took time during the meeting to review the highlights of their work throughout the year. Many legislative efforts are underway, and highlights of those can be found in our monthly newsletters. ASA currently has 27 active member organizations representing 3532 individual Licensed Acupuncturists (or state equivalent).

Report of the Legislative Committee

Tracy Soltesz presented the report of the ASA Legislative Committee which has targeted 6 recommendations for the coming year:

- 1. Improve access to acupuncture through regional insurance (commercial insurance plans and state Medicaid plans).
- Improve access to acupuncture through federal insurance coverage by producing educational documents on Medicare and Acupuncture, as well as Tricare.
- 3. Support passage of licensure acts in Michigan, Oklahoma, South Dakota, and Alabama, and remove physician oversight laws where still present.
- 4. Increase access to acupuncture in institutional settings such as military and hospitals (VA and DoD).
- 5. Increase legislative services provided to ASA membership such as federal and state-by-state legislative tracking, and the creation of resources for Lobby Day.
- 6. Improve communication between ASA members and organizations such as NCCAOM, ACAOM, and CCAOM.

ASA has invested in a state legislative tracking program as well. Please see our website to explore and learn more about how these resources can benefit our industry!


NCCAOM graciously took questions from the acupuncture community. A summary of those can be found here.

Defense and Veterans Center for Integrative Pain Management



The ASA was honored to be joined by US Army retired Colonel Kevin Galloway, now Deputy Director of DVCIPM to present both the new DVCIPM Pain Scale and to give an overview of the history and future of Licensed Acupuncturists in

the DoD and Veterans Administration. These agencies are very interested in Licensed Acupuncturists, but much work is needed to assist in inclusion. ASA is partnering with these agencies to work towards meaningful job opportunities in this arena. ASA is recommending that all acupuncture schools and practitioners initiate usage of the DVCIPM pain scale, as this is a validated tool that improves considerably on previous pain rating tools. CCAOM will also be promoting this resource.

State Organizations

ISO – International Organization for Standardization

Eric R. Buckley gave us an update on activities of ISO/TC249 which will be having its first-ever U.S. meeting in the coming years. Eric is now head of the U.S. ISO/TC249 delegation. ISO sets standards for everything from how your e-stim machine is calculated to the conformation of your acupuncture needles, and even to what species limitations there are on the ginseng you purchase. U.S. involvement is critical in this process and has been underrepresented in years past, so we thank Eric for his work, and thank the U.S. committee. For more on ISO see the ISO website, esp. AMA CPT Committee

ASA is increasing activity regarding involvement on the AMA CPT committee. Our profession is still not represented in this arena, as membership qualifications for interested organizations have been set as "50%+1" of the practitioner base. This means we need to have one group or possibly a coalition of groups representing more than 14,000 acupuncturists before our profession has a voice. The importance of involvement in the ASA structure has never been more evident than in this domain. ASA is discussing possibilities for a coalition with a number of groups. We are excited to have Mori West, owner of AcuClaims and well-known speaker on billing and coding, taking a role as an ASA delegate to the AMA CPT meetings. She and Kallie Guimond will represent the profession this coming year. Considering the importance of **CPT codes** towards insurance reimbursement within an ever-changing healthcare environment, monitoring the acupuncture codes and other codes commonly utilized by our providers is critical. The CPT committee meets **three times per year** in different parts of the country, so the financial tag on this is high. For how a code is developed, see **this resource**.

Accreditation Commission for Acupuncture and Oriental Medicine

Jason Wright joined us via the web to present on the status and major activities of the ACAOM. ACAOM has 55 institutions in 63 locations in 22 states, with 96 accredited/pre-accredited programs (25 MAc programs, 50 MOM programs, 4 Masters level programs, 10 accredited DAOM programs, 0 professional doctorate, pending meeting). Data analysis is still underway for the Degree Title Designation Project, with 1715 responses received. ACAOM is currently seeking Nominations for Commissioners, deadline April 15, 2018.

ACAOM thanks the ASA for leadership efforts on behalf of AOM, as well as steady participation in Delphi study and ongoing engagement with ACAOM.



Council of Colleges of Acupuncture and Oriental Medicine



Misti Oxford-Pickerel and new Executive Director Roberta Herman gave us an update on the work of the Council of Colleges. Membership of CCAOM is 55 institutions. CCAOM meets biannually in May and November. The on-going CCAOM strategic plan includes supporting the advancement and integration of AOM in US healthcare, increasing the visibility of the CCAOM as a national leader in the AOM profession, increasing collaboration with other relevant national organizations, and providing the long term financial stability of CCAOM. MOP is the CCAOM liaison to the ASA, working to promote school memberships in the ASA. RH is the new CCAOM ED, as she shares her experiences working with large organizations.

CCAOM has a college research grant which institutions with research committees can apply. As Gainful Employment is in flux, CCAOM will update us more after its May meeting.







Board Changes

While the current board values its service to the profession, we are designed to have strict turnover in board membership. This assures healthy governance turnover and brings new blood to the organization. Current board terms and status can be found here. Governance Committee Updates

Zeyiad Elias is serving as the Chair of the ASA Governance Committee. He presented the governance report, including review of the committee's purpose (which is to assure that ASA operates under its bylaws and adheres to all policy as determined by the Council). He also introduced work to be done over the coming year by this committee to develop policies and procedures for the development of organizational policy (a primary function of the ASA Council).

Nominating Committee Report

Candace Sarges, Chair of the **Nominating Committee**, presented the extensive work this group has done over 2017 in its efforts to develop vetting materials for both individuals wishing to join the ASA Board, and for organizations that meet ASA Bylaws requirements and wish to join ASA. **These are now available on the website**, and represent a phenomenal step towards proper governance and an ability to find the best, brightest, and most capable to serve the organization.

Public Education Committee

Lindy Camardella presented the work and goals of the committee. The PE Committee's focus is to bring a new level to a national awareness campaign. The committee initiated discussions with AcuTalks, created an Acupuncture Evidence Project Video, created the "10 Things You Need to Know about Acupuncture" flyer, and reached out to celebrities regarding acupuncture. The committee also worked with the Foundation for Chiropractic Practice (F4CP) to spread positive news about non-pharmacologic treatments for pain. Lindy expanded the committee as well, and now has extra council from Mr. Zach.



Infrastructure Development

We thank Olivia Hsu Friedman for doing extensive research to find an optimal web solution for the profession! After receiving 5 Membership Software proposals, Design & Promote, offered the best proposal for ASA and the states' needs. This platform offers Paid Membership Pro to house the ASA Website, as well as possible State Association sites, with customizable options. Events calendars can be added, so all state events can be in one location. Each state website will house its own RSS widget based on their needs. Practitioners will also be able to create their own websites based on templates. Websites will be WordPress based.



Budget Report



Candace Sarges, acting Treasurer, gave the annual budget report. Candace has worked tirelessly with a CPA to assure completeness and clarity of the budget. In 2017, ASA's income was \$40,191.17. Total expenditure was \$42,332.81. Fund balance as of 12/31/16 was \$18,272.48. Fund balance as of 12/31/17 was \$16,130.84.

American Alliance for Professional Acupuncture Safety

We were delighted to welcome AAPAS this year to help us better get to know one another as organizations. AAPAS is comprised of 39 organizations with Yong Ming Li as Chair. Hongjian He, Florida Acupuncture Association delegate, is also very involved with AAPAS. AAPAS is a 501(c)4 organization. The goals of AAPAS include the creation of a clearinghouse for information, provision of legal support to states working for acupuncture safety, education of professionals and the public, promotion of academic research and expertise, and the raising of funds for acupuncture. The organization also opposes the practice of acupuncture without a license.




Working Lunch Saturday

Owning Orthopedic Acupuncture and ICD 11

Marilyn Allen presented and moderated a discussion on conceptual options for the development of an industry specific course leading to a certificate in orthopedic techniques including "dry needling". This certificate would help identify and secure the place of LAc's in the increasingly competitive domain of musculoskeletal acupuncture for pain management. While many have learned these techniques in school, others did not have this as a core part of the curriculum. The Council was overwhelmingly enthusiastic about this option. An Update from POCA and POCA Tech

POCA has recently launched a valuable tool for the industry in the form of its "Adverse Event Database". Elizabeth Ropp, NH alternate delegate and member of POCA, presented this to the Council. The database can be accessed here, and ASA encourages practitioners to utilize this tool! ASA will be giving feedback to POCA on suggested improvements, and the tool itself incorporates an opportunity for user feedback. This is another step in promoting our own self-regulation as a profession.

Acupuncture is already a very safe practice. Your voluntary reports make it even safer by providing safety event information and using that information to conduct research, analyze and compile safety data, and refine acupuncture safety practices.

The Board will work to create an equitable rubric for designation of monies to this fund, and has developed a preliminary grant application process that can be found HERE. The value of the fund now stands at \$2000.

California at a Critical Juncture



California affects the industry with ½ of the US acupuncture licensees. Assemblymember Evan Low chairs the Business and Professions Committee, which oversees the California Acupuncture Board (CAB). He has hosted several meetings of the California acupuncture community. Currently, there are approximately 26 acupuncture groups in California. One

single unified acupuncture voice was requested, thereby asking existing groups to disband and rejoin into a new entity. Additionally, the California legislature would like to move towards national standards through the adoption of the NCCAOM exams.

There are 3 primary concerns that have been voiced by CA stakeholders in regards to the NCCAOM exams:

1. That the NCCAOM exam is perceived to be substantially different from and less difficult than California Acupuncture Licensing Exam (CALE). **This is untrue**, and an extensive linkage study has been performed showing the exams to be substantially equivalent. The exception is that the NCCAOM exam does not cover state specific laws, thereby, California would require a supplemental jurisprudence exam to cover California state law.

2. The NCCAOM exams have a lower educational hour requirement for sitting for the certification exam than CAB, and that this would thus lower educational requirements for practice in CA. **This is untrue**, in that the educational requirements to practice in CA can remain independent of the requirements for sitting for the NCCAOM exam. These are independent variables, not dependent variables. Though the exams may have different prerequisite requirements, CAB's educational requirements can still be greater than those of NCCAOM to allow licensure.

3. The cost of the exam. CALE is \$625, compared to approximately \$1800 for all modules of the NCCAOM exam. **This is a true concern**. NCCAOM testing, however, comes with significant conveniences such as year-round testing at free-standing centers and more support-infrastructure. This point remains in discussion.

If CA state organizations do not comply with the effort to unite, there is a risk for the sunsetting of the California Acupuncture Board. The CAB could be moved from independence back under the medical board, and this could dramatically affect licensing and regulation in the state, affecting the industry nationwide. ASA involved organizations CSOMA and CAA are at the forefront of these discussions, and have been assigned to the steering committee of the new organization. ASA as a national group remains as a resource to these organizations. From the national perspective, adopting

On Sunday, the ASA was delighted to receive a day of invaluable leadership training from industry experts!


